1. The basic daily care fee. The basic daily care fee is paid by every resident. It covers the daily living costs of personal care, some group activities, meals, cleaning, laundry and heating and cooling. The fee is set by the Commonwealth Government at 85% of the full single aged pension. It is adjusted twice a year in line with the Government's pension review.

2. The means tested care fee. The means-tested care fee is additional to the basic daily care fee. To find out if you are eligible for financial support from the Government an income and assets assessment is required. You may be eligible to receive support for some or all of the costs associated with your care and accommodation. To find out more about how eligibility is assessed go to humanservices.gov.au/agedcare or call 1800 227 475.

3. The accommodation payment. The accommodation payment includes the cost of your room, bathroom facilities, communal areas and where available private air conditioning. Accommodation payments can be a Refundable Accommodation Deposit (RAD) or a Daily Accommodation Payment (DAP) or a combination of both a RAD and DAP. You may be eligible to receive financial support in full or in part from the Government. This is determined when you complete an income and assets assessment application.

4. Additional services charges. These charges will vary depending on additional services requested by you and provided by Doutta Galla Aged Services.
